(ESHB 2261 required the hours to be implemented "according to an implementation schedule adopted by the legislature." The legislature has not adopted an implementation schedule. However, the 2011 legislature added the statutory requirement that implementation is to occur "not before the 2014-15 school year.")
- 3) K-12 salary reduction in the 2011-13 biennium is restored in the base.
- 4) Ramp-up years are shaded, with first year of full implementation in bold.
- 5) Total target cost of enhancements to basic education does not include any estimated policy changes to compensation.
