## **U.S.-China Clean Energy Trade Complaints**

#### U.S. Antidumping and Countervailing Duties on PRC Solar Panels

 November 2011: US initiates AD and CVD cases against imports of Chinese solar panels

#### Chinese Investigation of Six State Renewable Energy Programs

- Ohio, Massachusetts, California, and New Jersey (2) and Washington Renewable Energy Cost Recovery Program
- U..S. response to PRC questionnaire
- August 2012: China announces final determination that all six subsidies are "prohibited" subsidies under WTO rules
- Next Steps?

# U.S.-China Clean Energy Trade Complaints, Cntd.

#### Washington Renewable Energy Cost Recovery Program

- Originally passed in 2005 (SB 5101) but amended several times.
- Incentive for businesses, consumers and local governments to generate electricity from wind power, solar power and anaerobic digesters.
- Amount of incentive paid to the producer by the utility starts at a base rate of \$0.15 per kilowatt, varying according to the technology.
- Additional incentive if equipment is produced in Washington.
- Participating utilities can claim a utility tax credit.

## US-China Clean Energy Trade Complaints, Cntd.

#### Chinese AD and CVD Investigation of U.S. Polysilicon Imports

- July 2 China initiates trade cases
- Dumping (AD) involves the pricing policies of U.S. companies
- Countervailing Duty Cases involve subsidies
  - Washington
    - RCW 82.04.294 Reduced B&O Rate (0.275%) for solar grade silicon (and other products)
    - RCW 82.04.4452 B&O R&D Tax Credit for Certain Industries (advanced computing, advanced materials, biotechnology, electronic devices, environmental technology)
- PRC preliminary determination late this year or early next year

### RECENT FREE TRADE AGREEMENTS

#### U.S.-Korean FTA (Implemented March 15, 2012)

- Total Washington exports up 36%
- Agricultural Exports (April to August 2012)

Total WA Ag Exports: $328 million ----- 91% increase%
Cherries: $22.7 million ----- 86% increase
French fries: $28.0 million ----- 51% increase
Wheat: $173 million ----- 182% increase
Hay: $36.3 million ----- 20.6% increase

#### U.S.- Colombia and Panama FTAs
